

# **ATTENTION ALL STUDENTS** **ENROLLING FOR SUMMER I, SUMMER II AND FALL 2016**

## **\*\*\*\*\* IMPORTANT PAYMENT DEADLINE INFORMATION \*\*\*\*\***

Tuition and fees are due BEFORE classes begin. The deadline to pay your charges for Summer I, Summer II and Fall 2016 is 5:00pm on the deadline date for each term. See below for the deadline dates for Summer I, Summer II and Fall 2016.

IF FULL PAYMENT AND/OR ARRANGEMENT (FINANCIAL AID OR INSTALLMENT PLAN) HAS NOT BEEN MADE BY THE DEADLINE DATE FOR THE TERM, YOU MAY BE DROPPED FROM YOUR CLASSES. Installment plans will be available July 5, 2016, for the fall 2016 term. *Installment plans are not available for Summer I and Summer II terms.*

If you register after the deadline date for a term, or you are dropped and re-register, you will have until 5:00pm on the subsequent drop date for that term to pay in full or have an arrangement (financial aid or installment plan – if available) in place to avoid being dropped from your classes.

If you register after the subsequent drop date for a term, or you are dropped and re-register, you will have until 5:00pm on the final drop date for that term to pay in full or have an arrangement (financial aid or installment plan – if available) in place to avoid being dropped from your classes **OWING A PRORATED PORTION OF TUITION AND FEES.**

**Students with Financial Aid** – All financial aid needs to be in place and reflected on your student account by the deadline in order to impact your net balance due. If you do not have enough aid to cover your charges by this date, you will need to pay your net balance in full or set up an installment plan in order to stay enrolled. \*\*The amount of financial aid that a student is eligible to receive during the summer is calculated based on the student's enrollment on the 5<sup>th</sup> day of class of the **first summer term**. Any classes added after the 5<sup>th</sup> day of the first summer term, including classes for the second summer term, will not be considered for financial aid.\*\*

**Students with Third Party Contracts** – All third party contracts (TAA, AR Rehab, VA, etc.) must be received by **UAFS by the deadline in order to impact your net balance due**. If you do not have enough aid (financial aid or third party contract) to cover your charges by this date, you will need to pay your net balance in full or set up an installment plan in order to stay enrolled.
